### RULES AND REGULATIONS

1. Every class offered herein which is covered by the rules and specification of the current USEF Rule Book will be conducted and judged in accordance therewith

2. Exhibitors must be in proper riding attire and wear protective headgear

**3.** Hunter classes to be judged on soundness and performance. Any additional specification will be noted. Trophy and eight ribbons awarded in every class, unless otherwise noted. Prize money to be deducted from entry fees.

4. Hunter coursesinclude: gates, brush, walls, oxers, in and out, coopsrails or any combination thereof.

5. Jumper coursesinclude: postand rail, gates, oxers, walls, panels, coopsor any combination thereof.

6. Hunter champions will be awarded in accordance with USEF rule HU138 & HU139.

8. Ring dimensions and footing: Hunter ring 140' x 250', Sand ring 150' x 300', Indoor ring 114' x 195'. Footing in all rings is sand/fiber mix. Stalls are in permanent building with mat flooring.

9. If jumping orders are to be used, the horse's names will be drawn individually starting with the first position then working down. Orders will be announced and posted one hour before the class. A dotted line may be instituted to limit the size of opening circles if entries require.

10. The Management reserves the right to cancel, combine or split any class if entries warrant or the rules of the USEF require it and to limit the number of entries accepted, which will be done on a first come first serve basis. Post entries will be accepted iftime allows.

11. Every animal entered for competition or on the show grounds shall be under the control of the horse show committee. Old Salem Farm and/or its employees shall not be liable or responsible for any loss or damage to any animal, person or property, which may occur for any reason during the show and it shall be a condition of entry that each exhibitor hold Old Salem Farm, its owners, agents, employees and the USEF blameless for any accident or loss which may occur.

12. A fine of \$50.00 plus collection fees will be assessed for all non-negotiable checks. Foreign competitors are required to pay in US funds to avoiddiscountcharges.

13. No dogs or other pets allowed on the groundsunless leashed and under control.

14. Measurements to be done by Miller & Associates by appointment with horse show office. 10:00 AM LIFE, SENIOR ACTIVE, JUNIOR ACTIVE MEMBERS SHALL BE ELIGIBLE TO PARTICIPATE IN ALL CLASSES AT REGULAR COMPETITIONS, EVENTING COPETITIONS AT THE PRELIMINARY LEVEL OR ABOVE AND COMBINE DRIVING COMPTETITIONS AT THE ADVANCED LEVEL, DRESSAGE, REINING AND VAULTING COMPETITIONS AND ENDURANCE RIDES A NONMEMBER MAY PARTICIPATE AS A HANDLER, RIDER, DRIVER, OWNER, LESSEE, AGENT, COACH OR TRAINER AT REGULAR MEMBER COMPETITIONS, EVENTING COMPETITIONS, AND COMBINED DRIVING COMPETITIONS UPON PAYMENT OF A \$30 SHOW PASS FEE. PARTICIPANTS IN THE FOLLOWING CLASSES ARE EXEMPT FROM THE REQUIREMENTS OF THIS RULE: 1. LEADLINE; 2. EXHIBITIONS; 3. GAMES AND RACES 4. CLASSES FOR 4-H MEMBERS AND 5. WALK TROT AND ACADEMY CLASSES (academy classes are classes limited to horses used regularly in a lesion program); 6. USDF INTRODUCTORY LEVEL TESTS, PAS DE DEUX AND QUADRILLE CLASSES; 7. NRHA ENDORSED REINING COMPETITIONS AND OPPORTUNITY CLASSES ALSO EXEMPT FROM THIS REQUIREMENT ARE CITIZENS OF OTHER NATIONS WHO HAVE PROOF IN ENGLISH, OF CURRENT MEMBERSHIP IN GOOD STANDING OF THEIR OWN NATIONAL FEDERATION, AND 8. USEA BEGINNER NOVICE DIVISION; AND 9. ASSISTANT HANDLERS IN DRESSAGE SPORT HORSE BREEDING CLASSES.

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR218) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and

("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors,, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, with-out limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers (**"Risks"**).

### WARNING:

WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (Individually and Collectively, the "Released Parties" or "Event Organizers"), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.
