**** PLEASE NOTE:** Membership in the National Horse Show Association (NHSAA) is required for all riders and trainers who have riders competing in the ASPCA Maclay. The membership/qualifying year is September 1 –August 31. ******

Entries and Entry Closing Dates for Regionals

Entries for Regional Maclay Championship classes close, and must be received by, 5:00 p.m. Eastern Time, September 1, at the NHSAA's office, except if that date should fall on a Sunday, in which case they must be received no later than 5 p.m. on the following Monday. Entries must be on the Official Entry Form, signed, and submitted with the \$150.00 per class Entry Fee made payable to the NHSAA. The NHSAA reserves the right to reject any late or unsigned entries or entries not submitted with all entry fees. Entries may not be accepted directly by any Regionals competition

Any additional fees (stalls, office, USEF, etc.) are to be paid by separate Old Salem Farm Entry Form to the Regional competition.

The National Horse Show Association of America, Limited ("NHSAA") is responsible for the organization, presentation and administration of the Maclay Trophy and the associated competitions, including the Maclay Regional Championship ("Regionals") and Maclay National Championship ("Finals") Classes. To ensure the selection of appropriate sites, judges and course designers, the NHSAA communicates with the Joint Equitation Task Force of the United States Hunter Jumper Association (USHJA), the National Horse Show Association Equitation Committee and on other matters with the American Society for the Prevention of Cruelty to Animals ("ASPCA"). USEF rules govern these competitions and the Maclay National Championship Qualifying Classes ("Maclay"). In case of any conflict between these Rules and USEF rules, USEF rules shall govern.

Specifications for all Maclay, Regionals and Finals Classes The Maclay is open to junior members of USEF or Equine Canada who have not reached their 18th birthday in accordance with GR127. Riders must be current members of the National Horse Show Association ("NHSAA") in order to compete in all Maclay, Regionals and Finals Classes. Trainers (or coaches when applicable [see USEF GR108]) of riders competing in all Maclay, Regionals and Finals Classes must also be members of the NHSAA. The NHSAA Membership year is September 1 through August 31. Junior rider annual contributions shall be \$35. Trainer (or coach) annual contributions shall be \$50. A rider may enter any Maclay anywhere in the United States according to the conditions published in the current Rule book of the USEF. Any rider in his or her final junior year may not compete in any qualifying classes held at a competition with a start date after August 31 of that competition year. Previous winners of the Finals are ineligible to compete in any Maclay Class, Regionals or Finals.

Course:

The course for each Regionals shall be designed by a USEF Course Designer who must be selected and/or approved by the NHSAA. Any Regionals course must adhere to the above stated specifications and be of sufficient difficulty to typify the Finals and reflect the importance of the class. While the courses at all Regionals need not be identical, they should reflect equal difficulty and challenge.

Judging:

Each Regionals shall have two (2) "R" Judges. One of these judges must be selected from the approved list of judges supplied by the NHSAA. The second judge is not required to be selected from this list but must be approved by the NHSAA. Judges for the Finals are ineligible to judge any Regionals in the same year. Riders are to be judged on seat, hands, guidance and control of horse. Two refusals will eliminate a rider from Regionals competition. Use of the open numerical system of judging not to be used. After completion of the jumping phase, if available, a minimum of ten (10) more riders than one-half the number of riders competing in the Regionals are required to show at a walk, trot and canter. At the sole discretion of the judges, additional flat work may be called for, but all groups must be asked to perform the same tests. No more than twenty (20) riders at a time may be asked to work together in a group at the same time. The flat performance of those riders selected to show in the flat phase shall count 50%. Changing of bit/bridle between phases is permissible. After the flat phase the Judges may request further testing using USEF tests 1-16. Riders may only be selected for further testing if after the flat phase they are already assured an invitation (based on percentages) to compete in the Finals. The Judges will select a Champion, Reserve Champion, and Third through Tenth place finishers at each Regionals. In addition, the judges will determine a stand-by list of all the additional entrants who returned for the flat phase. This stand-by list will be announced publicly, made available to all competitors and emailed to the NHSAA office. When the Regionals are completed and the riders qualified for the Finals have been selected the judge's cards will be immediately sealed. The judge's cards and a detailed copy of the course diagram will be emailed directly to the NHSAA office.

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

RULES AND REGULATIONS

1. Every class offered herein which is covered by the rules and specification of the current USEF Rule Book will be conducted and judged in accordance therewith.
2. Exhibitors must be in proper riding attire and wear protective headgear.
3. Hunter classes to be judged on soundness and performance. Any additional specification to be noted. Trophy and eight ribbons awarded in every class, unless otherwise noted. Hunter champions will be awarded in accordance with USEF rule HU138 & HU139. All other champions awarded as specified.
4. Prize money will be deducted from entry fees. Any additional monies will be mailed by check within 30 days. The Horse Show will not stop payment or duplicate awards for lost checks.
5. Stabling available on a first come, first serve basis. Stalls provided will be under canvas and are 10'x1. Stable doors are provided. Stable floor is matted. Stalls are \$250.
6. An office fee of \$40.00 will be assessed to every entry.
7. An entry may be scratched by written notice with the show secretary and a \$40.00 processing fee will be assessed. Once the show has started, horses that are not shown in classes in which they are entered will forfeit their entry fees.
8. A fine of \$50.00 plus collection fees will be assessed for all non-negotiable checks. Foreign competitors are required to pay in US funds to avoid discount charges.
9. Ring dimensions and footing: Hunter ring 140' x 250', Sand ring 150' x 300', Indoor ring 114' x 195'. Footing in all rings is sand/fibermix.
10. If jumping orders are to be used, the horses' names will be drawn individually starting with the first position then working down. Orders will be announced and posted one hour before the class. A dotted line may be instituted to limit the size of opening circles if entries require.
11. The Management reserves the right to cancel, combine or split any class if entries warrant or the rules of the USEF require it and to limit the number of entries accepted, which will be done on a first come first serve basis. Post entries will be accepted if time allows.
12. Every animal entered for competition or on the show grounds shall be under the control of the horse show committee. Old Salem Farm and/or its employees shall not be liable or responsible for any loss or damage to any animal, person or property, which may occur for any reason during the show and it shall be a condition of entry that each exhibitor hold Old Salem Farm, its owners, agents, employees and the USEF blameless for any accident or loss which may occur.
13. No dogs or other pets allowed on the grounds unless leashed and under control.
14. Measurements to be done by Miller & Associates by appointment with show office 10 AM.
15. Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.



WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and _____ ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors,, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

WARNING:

HORSEBACK RIDING AND EQUINE ACTIVITIES CAN BE DANGEROUS. RIDE AT YOUR OWN RISK. Under the laws New York, an equine activity sponsor or equine professional may not liable for any injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities. See SECTION 18-301-303 OF THE GENERAL OBLIGATIONS LAW.

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the USEF Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any USEF Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (**Individually and Collectively, the "Released Parties" or "Event Organizers"**), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("**Liability**") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

I HAVE CAREFULLY READ THIS DOCUMENT IN ITS ENTIRETY, UNDERSTAND ALL OF ITS TERMS AND CONDITIONS, AND KNOW IT CONTAINS AN ASSUMPTION OF RISK, RELEASE AND WAIVER FROM LIABILITY, AS WELL AS A HOLD HARMLESS AND INDEMNIFICATION OBLIGATIONS.

By signing below, that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies as published at www.usef.org, as amended from time to time, as well as all terms and provisions of this Prize List. If, despite this Agreement, I, or anyone on my behalf or the minor's behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liabilities as the result of such claim.
